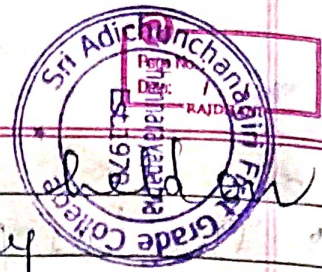


## Meeting - II
