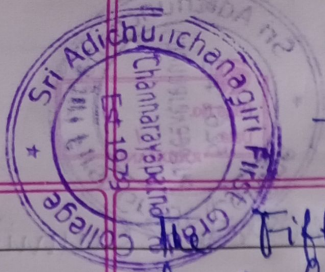



Grievance Redressal committee held a meeting on 07/01/2023 at the library

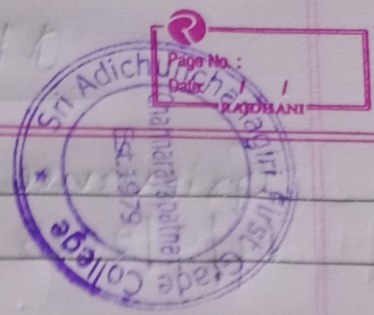
At the outset Mrs. Alingaraju convenor of the committee welcomed all the Guest members of the committee.
