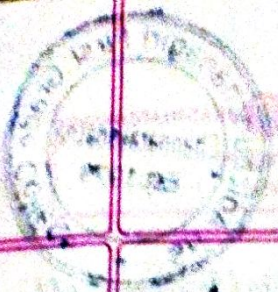

Report on Awareness of Foetus should not be removed

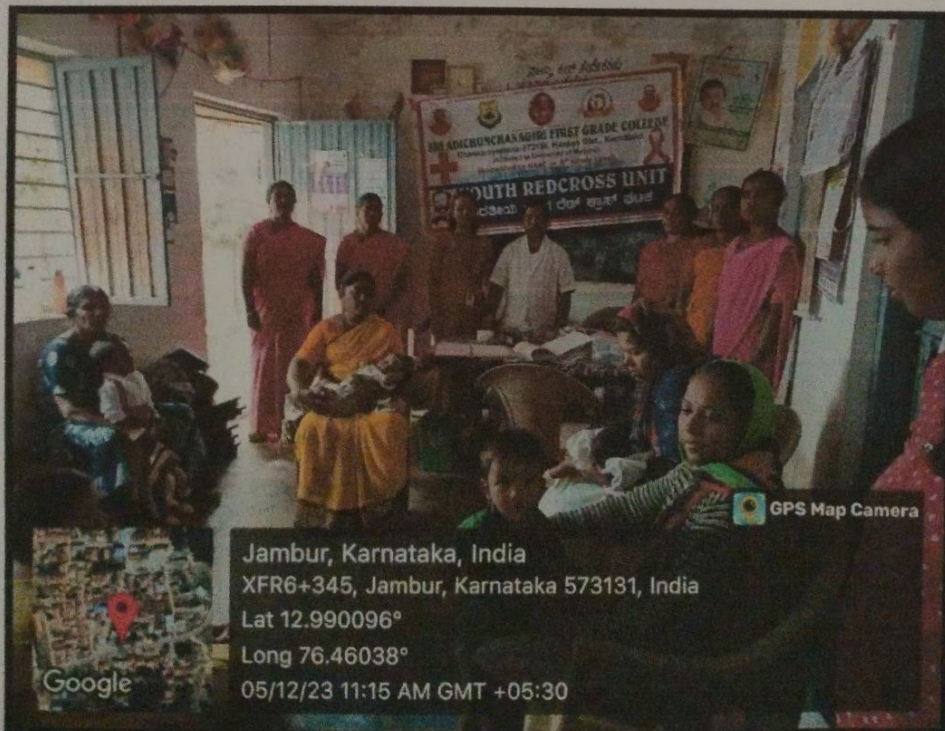

Nurse J.D. Ratna said that after removing the Foetus, she informed the villagers about the health condition of the mother and told them about the challenges she would face when she wants to become a mother again.

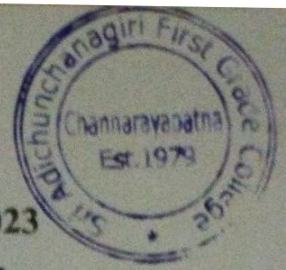

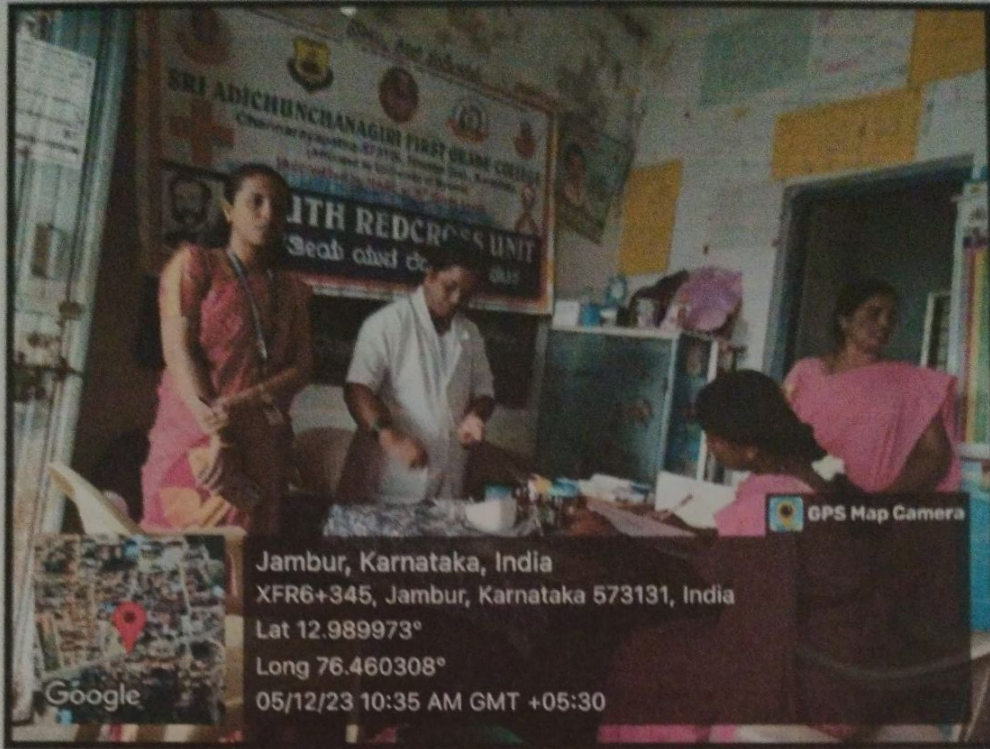
